EXECUTIVE ACTIONS IN THE PAST WEEK

The Biden Administration has taken immediate steps in a number of policy areas through Executive Orders, memoranda, and other actions. The latest efforts, since our last tracker, include:

- Announced starting on April 19th, all adults will be eligible for COVID vaccinations.
- Executive Order terminated the emergency declared in Executive Order 13928 of June 11, 2020, which blocked the property of certain persons associated with the international criminal court.
- Announced the American Jobs Plan focused on physical infrastructure and including provisions on broadband and clean energy technology.
